## INSTRUCTIONS FOR COMPLETING THIS FORM

#### **General Information**

Lookups of driving and vehicle records are available for \$7.00 for each record lookup. Certifications cost an additional \$1.00 per record. If no record is found, you are still responsible to pay the lookup fee(s).

Fill out as much information about your request as you can. Accurate and complete information will help us locate the record(s) you want. Please include a daytime telephone number in case we have questions about your request.

All requestors must select at least one of the permissible purposes in Section 4 if personal information contained in the record is needed. Personal information will be redacted (not revealed) if the requestor has not designated a permissible purpose.

#### **Driving Records and Personal Identification Card Information – Section 2**

For driving records, include as much detail in Section 2 as possible. If you just need the name, address, or driving status, request the current record only. If you check more than one box, you will be charged for each record lookup.

Personal identification card information is also available. Complete Section 2, Driver Information, substituting the identification card number for the driver's license number.



*IMPORTANT:* If you only need a driving record, <u>do not</u> complete Section 3; otherwise, you will also be charged for vehicle record lookups.

### Vehicle Registration or Title Information – Section 3

For vehicle information, include as much detail as possible. The owner's name should be the owner of record, not a purchaser who has not yet titled the vehicle. If you just need name, address, or ownership verification, request only a registration record. If you request both a registration record and current title information, you will be charged for two records (at least \$14.00). **Information about proof of insurance at vehicle registration is not retained and <u>is not</u> available.** 

For watercraft, snowmobile, ORV, or mobile home records, complete Section 3, Registration or Title Information, substituting the watercraft or snowmobile registration number for the license plate number or substituting the mobile home serial number for the vehicle identification number. Include as much information as you can about the watercraft, snowmobile, ORV, or mobile home.

If you request record information on a specific individual, **all** other names appearing within the documents that you receive will be redacted (not revealed). *Example: If you need all the names associated with a vehicle title history and you provide what you think is the current owner's name, all other names within the documents that you receive will be redacted. Leave the owner's information blank if you need personal information about all owners within the records. You must have a permissible purpose as outlined by state and federal laws to obtain personal information on all owners. If you do not have a valid permissible purpose, personal information will be redacted from the record(s) you receive.* 



*IMPORTANT:* If you only need vehicle registration or title information, <u>do not</u> complete Section 2; otherwise, you will also be charged for driving record lookups.
